







PEX PharmaSequence monthly report - March 2019 PEX PharmaSequence commentary

The pharmacy market in March 2019 reached the value of sales around 3 103m PLN. Value of sales compared to March 2018 fell by 7.8m PLN (-0.3%). Compared to February of 2018, sales grew by approximately 51.4m PLN (+1.7%).

Compared to the same period of 2018 the value of tracked segments was growing for non-prescription segment, value of the other fell. Sales based on non-reimbursed prescriptions grew by 21.2m PLN (+3.2%). The non-prescription segment fell by 14.5m PLN (-1.1.%) and on reimbursed prescriptions fell by 15.7m PLN (-1.5%).


Compared to the previous month, value of products sold without a prescription was smaller by approximately 16.6m PLN (-1.2%). Value of non-reimbursed prescriptions was higher by 26m PLN (+3.9%) and of reimbursed Rx drugs grew by 41.1m PLN (+4.0%).

The average retail drug price in March 2019 was 21.3 PLN and was 1.5% higher than in the previous month, and 4.3% higher than the average price in March 2018. The average retail price of reimbursed prescriptions was 28.3 PLN (+0.7% vs March 2018), 26.0 PLN for non-reimbursed prescriptions (+3.8% vs March 2018) and 16.4 PLN for products sold without a prescription (+5.7% vs March 2018).

Average pharmacy margin for all drugs in March 2019 was 24.8% and was lower by about 0.4pp than the margin in the same period of 2018. Compared to February 2019, the average pharmacy margin fell by approximately 0.1pp.

Drug reimbursement by the National Health Fund in March was in the amount over 789m PLN, 1.6% more than in the same period of 2018. The level of patient copayment for reimbursed drugs in March was 25.4%, higher by 0.7 pp. compared to previous month.


