







PEX PharmaSequence monthly report - October 2019 PEX PharmaSequence commentary

The pharmacy market in October 2019 saw sales go close to 3 437.2m PLN. Value of sales compared to October 2018 grew by over 257.5m PLN (+8.1%). Compared to September of 2019, sales grow by approximately 366.4m PLN (+11.9%).

Compared to the same period of 2018 the value of tracked segments grew for all monitored segments. Sales based on non-reimbursed prescriptions grew by 89.4m PLN (+12.9%), the non-prescription segment grew by 118.2m PLN (+8.8%), sales based on reimbursed prescriptions grow by 47.4m PLN (+4.2%).


Compared to the previous month, value of sales grew for all monitored segments. Value of reimbursed prescriptions grew by 157.9m PLN (+15.6%), value of non-reimbursed Rx drugs grew by 104.5m PLN (+15.5%) and value of products sold without a prescription grew by 99.8m PLN (+7.3%).

The average retail drug price in October 2019 was 21.9 PLN and was 1.4% higher than in the previous month, and 3.5% higher than the average price in October 2018. The average retail price of reimbursed prescriptions was 28.7 PLN (+1.4% vs October 2018), 27 PLN for non-reimbursed prescriptions (+4.2% vs October 2018) and 16.8 PLN for products sold without a prescription (+4.6% vs October 2018).

Average pharmacy margin for all drugs in October 2019 was 24.8% and was lower by 0.9% than margin in the same period of 2018. Compared to September 2019, the average pharmacy margin was lower by 2.2%.

Drug reimbursement by the National Health Fund in October was in the amount almost **881**m PLN, 6.1% more than in the same period of 2018. The level of patient copayment for reimbursed drugs in October was 25.6%, grew by 0.8p.p. compared to previous month.


