










## PEX PharmaSequence monthly report - October 2020 PEX PharmaSequence commentary

The pharmacy market in October 2020 saw sales go close to 3 596.3m PLN. Value of sales compared to October 2019 grew by 159.1m PLN (+4.6%). Compared to September of 2020, sales grew by approximately 390.4m PLN (+12.2%).

Compared to the same period of 2019 the value of tracked segments grew for two monitored segments. Sales based on reimbursed prescriptions fell by 35.5m PLN (-3%), sales based on non-reimbursed prescriptions grew by 14.1m PLN (+1.8%), the non-prescription segment grew by 180.2m PLN (+12.4%).


Compared to the previous month, the value of tracked segments grew for all monitored segments. Value of reimbursed prescriptions grew by 93.2m PLN (+8.9%), value of non-reimbursed RX drugs grew by 68.3m PLN (+9.4%) and value of products sold without a prescriptions grew by 226.3m PLN (+16%).

The average retail drug price in October 2020 was 22.7 PLN and was 0.7% lower than the average price in the previous month, and 3.7% higher than the average price in October 2019. The average retail price of reimbursed prescription was 29.1PLN (+1.4% vs October 2019), 29.5PLN for non-reimbursed prescriptions (+9.5% vs October 2019) and 17.7PLN for products sold without a prescription (+5.5% vs October 2019).

**Average pharmacy margin for all drugs in October 2020** was 25% and was higher by 1% than margin in the same period of 2019. Compared to September 2020, the average pharmacy margin was lower by 2.3%.

**Drug reimbursement by the National Health Fund** in October was in the amount 852m PLN, 3.3% less than in the same period of 2019. The level of patient copayment for reimbursed drugs in October was 23.7%, fell by 0.8p.p. compared to previous month.


