





- Total monthly sales in an average pharmacy in PLN -











PEX PharmaSequence monthly report – December 2021 PEX PharmaSequence commentary

The pharmacy market in December 2021 saw sales go close to 3959.1m PLN. Value of sales compared to December 2020 grew by 781.2m PLN (+24.6%). Compared to November of 2021, sales grew by approximately 240m PLN (+6.5%).

Compared to the same period of 2020 the value of tracked segments grew for all monitored segments. Sales based on reimbursed prescriptions grew by 144.2m PLN (+13.7%), sales based on non-reimbursed prescriptions grew by 242.9m PLN (+33.3%), the non-prescription segment grew by 388.7m PLN (+28.3%).


Compared to the previous month, the value of tracked segments grew for all monitored segments. Value of reimbursed prescriptions grew by 56.7m PLN (+5%), value of non-reimbursed RX drugs grew by 53.7m PLN (+5.8%) and value of products sold without a prescriptions grew by 129.3m PLN (+7.9%).

The average retail drug price in December 2021 was 24.6 PLN and was 1.1% higher than the average price in the previous month, and 5.7% higher than the average price in December 2020. The average retail price of reimbursed prescription was 30.6 PLN (+2.9% vs December 2020), 31.6 PLN for non-reimbursed prescriptions (+7% vs December 2020) and 19.6 PLN for products sold without a prescription (+9.1% vs December 2020).

Average pharmacy margin for all drugs in December 2021 was 25.4% and was higher by 3.7% than margin in the same period of 2020. Compared to November 2021, the average pharmacy margin was higher by 0.2%.

Drug reimbursement by the National Health Fund in December was in the amount 896m PLN, 12.9% more than in the same period of 2020. The level of patient copayment for reimbursed drugs in December was 22.6%, fell by 0.2p.p. compared to previous month.


